As a club that operates in California, we adhere to the state regulations regarding membership applications. Please read through the following guidelines before submitting your application.

### Membership Eligibility:

- Applicants must be 18 years or older.
- Applicants must be able to swim at least 50 yards without assistance.
- Applicants must have a valid driver's license.
- Applicants must provide proof of liability/health insurance.

### Membership Application Process:

1. Fill out the Membership Application Form (attached to this email).
2. Sign and date the Waiver of Liability Form available on the resources page of our website, as well as on: <https://waiver.smartwaiver.com/w/94n4mutvmmu1cq9p8ek3o/web/>
3. Submit your completed forms along with your proof of liability insurance to [california@skiparadise.com](mailto:california@skiparadise.com)
4. Upon receipt of your application, the Board of Directors will review it for eligibility and vote on your acceptance.

## Membership Dues:

- Paradise Ski Club membership dues depend on the type of membership you opt for.
- Payments are due at the time of application approval and are non-refundable.

By submitting your application you will agree to the Paradise Ski Club General Conditions and rules of operation present below:

## General Conditions & Rules of Operation

In order to promote a healthy and efficient environment at the club we have designed a series of regulations that will work in everyone's best interests, and are aligned with California's state regulations for a Ski Club. Here they are:

- Months of operation: May 1st to November 1st 2023
- Hours of operation:
  - Mondays thru Fridays 8am - 1pm and 3pm - 7pm
  - Weekends 8am - 1pm and 2pm - 5pm
- Club AWSA sanctioned Driver will be available with club boat during all operating hours
- Sets are 6 passes or 15 minutes (reasonable exceptions always available)
- Life Jackets: All individuals must wear Coast Guard-approved personal flotation devices (PFDs) while engaged in any water activities.

- Alcohol and drugs: No individual may operate or participate in water activities while under the influence of drugs or alcohol.
- Water skiing: When water skiing, only one person may ski behind a boat at a time, and the boat must be equipped with a rearview mirror for the driver.
- Age requirements: Individuals under the age of 16 must be accompanied by an adult or 18+ club member while engaged in water activities.
- Drowning prevention: All members must be aware of the club's safety protocol.
- Vessel safety: All vessels used by the club must comply with state and federal safety regulations.
- Environmental protection: Members must observe and comply with all environmental protection laws and regulations, including avoiding damage to marine wildlife and habitats.
- Emergency procedures: All members must be familiar with the club's emergency procedures, including communication channels, evacuation plans, and emergency equipment.
- Insurance: The club must have liability insurance coverage for all water activities.
- Respect for the staff, property, and other members
- No pets allowed
- The club should designate a safety officer or safety committee responsible for ensuring that all safety equipment is present, in good working order, and properly used by members.
- All members who wish to operate a boat for waterskiing must hold a valid California boater's license or a USA Waterski permit.
- The club's board reserves the right to revoke memberships if general conditions are violated without the responsibility to make any refunds.
- The club's board has the right to refuse or reject applicants that may not be considered fit for the club.
